**TRADE NOTICE NO. 04/2017**

**SUB: DIFFICULTIES FACED BY EXPORTERS OF PRODUCTS OF ANIMAL ORIGIN – OPENING OF THE FACTORY STUFFED CONTAINERS AT THE PORTS / ICDS – REG.**

Attention of Importers/Exporters/Trade/CBs is invited to the difficulties faced by exporters of products of animal origin regarding opening of the factory stuffed containers at the ports / ICDS.

It is to inform all the trade concerned that preferential treatment is given to factory Stuffed Containers and accordingly interdiction is minimized for Factory Stuffed Containers and exempt them from the requirement of examination at the Ports/ICDS. However, owing to following situation some time factory stuffed containers are picked up for examination at the Ports / ICDS.

It has been observed that many a times the exporter does not declare the distinctive Seal Type for the Factory Stuffed Containers (i.e. Seal Type "A") at the on-submission stage of the Shipping Bill. RMS processing takes place at on-submission stage and since the entry relating to Seal Type is left blank, the shipment is understood by RMS as other than Factory Stuffed. Accordingly, the exemption from interdictions as envisaged for Factory Stuffed Containers is not accorded and consignments get flagged for examination. To resolve this issue the Export Councils and CHA's needs to educate its members the imperative need to declare Seal Type at on-submission stage. Trade is accordingly advised to correctly declare the distinctive seal type at the time of submission of Shipping Bill to avoid any inconvenience.

Any difficulties in the implementation of the same may be brought to the notice of the undersigned.
