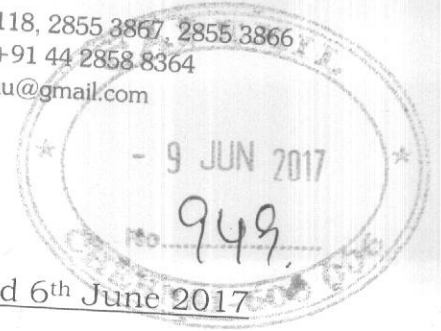

India and Eurasian Economic Union had undertaken a Joint Feasibility Study on the Free Trade Agreement (FTA) between the EAEU and its member states and republic of India in June 2015. The report has been finalized and its recommendations have been accepted by both the parties. Eurasian Economic Union (EAEU) constitutes 5 member countries, viz., Armenia, Belarus, Kazakhstan, Kyrgyzstan and Russian.

The Joint Feasibility Study Group (JFSG) report has concluded that the proposed FTA is feasible and mutually beneficial with substantial Welfare gains and augmentation in trade in goods. The negotiations for India - EAEU Free Trade Agreement are likely to commence soon. Successful conclusion of this trade negotiation will open new opportunities for Indian exporters in a new market whose potential has largely remained untapped.

In this background, Ministry of Commerce, Government of Indian has convened a "Stakeholder Consultancy Meeting" at Hotel Taj Coramandel as hereunder:-


