Sub: Ship to Ship (STS) LPG/LNG Operation at Sandheads and Sagar anchorage.

As approved by the Competent Authority, the following promotional rates for STS operation undertaken at Sandheads within the Port limit of SMPK, which are destined not to any of the landing places of Kolkata Dock System (KDS) and/or Haldia Dock Complex (HDC), and the transhipped cargo moving to a country outside India, will be applicable with immediate effect:-
